Re: Final Response to Request for Access to Information – Full Access
FOIP Request No.: 2013-G-0314

This is in response to your request for access to information of The City of Calgary in accordance with the *Freedom of Information and Protection of Privacy Act (The Act)*.

Please find enclosed 2 pages of records responsive to your request. The information provided is only for short term sickness and accident payments. Long term disability is provided through Great West Life; their contract is with the Municipal Employees Benefit Association of Calgary (MEBAC). MEBAC is made up of representatives of all unions and associations of The City of Calgary, excluding Calgary Fire Department, and is not owned or created by The City of Calgary. We are unable to provide records regarding the costs of long term disability payments as The City does not have a right of access to those records, nor to the management of those records.

Section 65 of the *Freedom of Information and Protection of Privacy Act* provides that an applicant may make a written request to the 'Office of the Information and Privacy Commissioner' (OIPC) of Alberta to review this decision. To request a review, you must complete and deliver a *Request for Review* form within 60 days from the date of this notice to:
