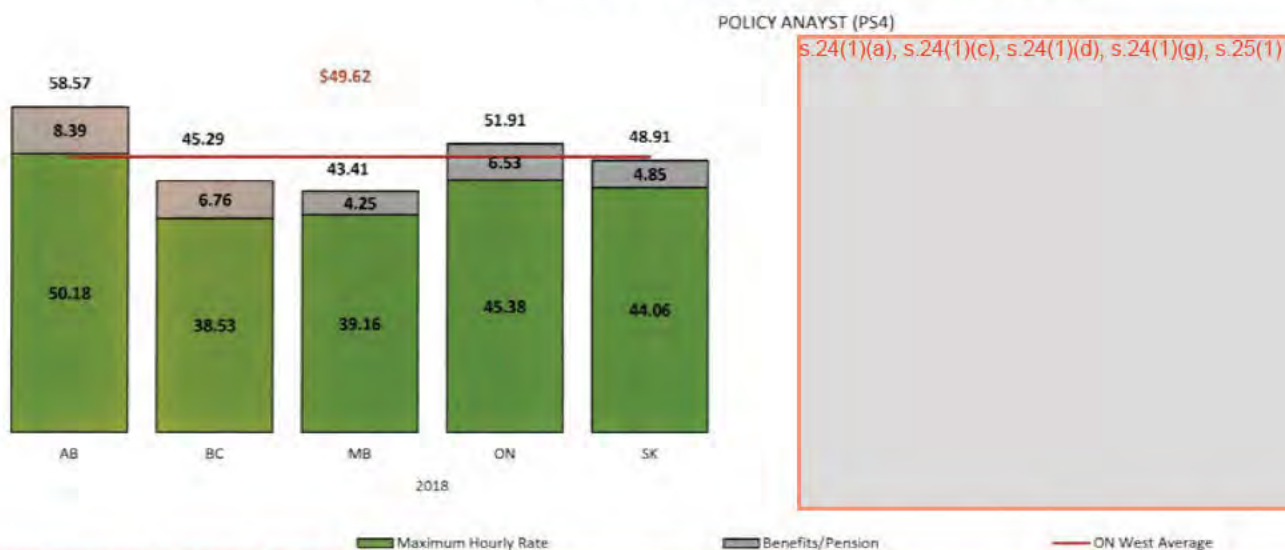

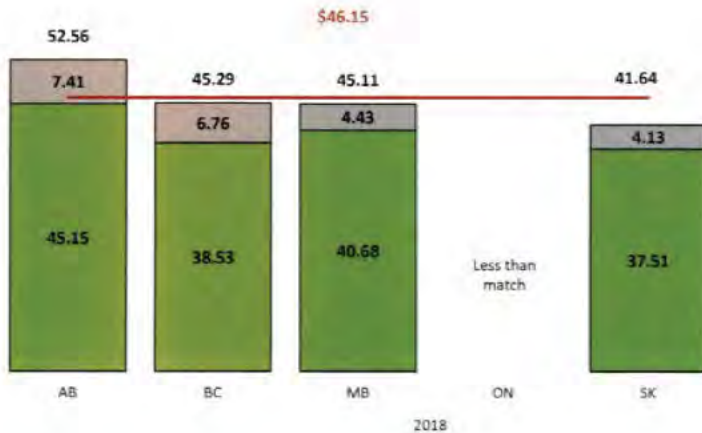


Figure 30: Child Welfare Case Worker (HS5)

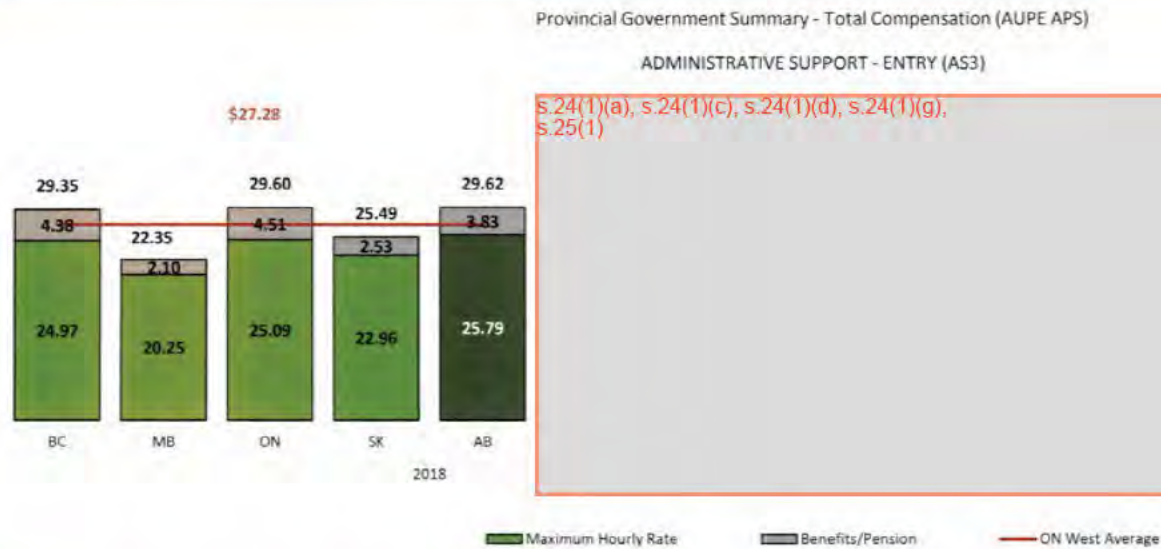

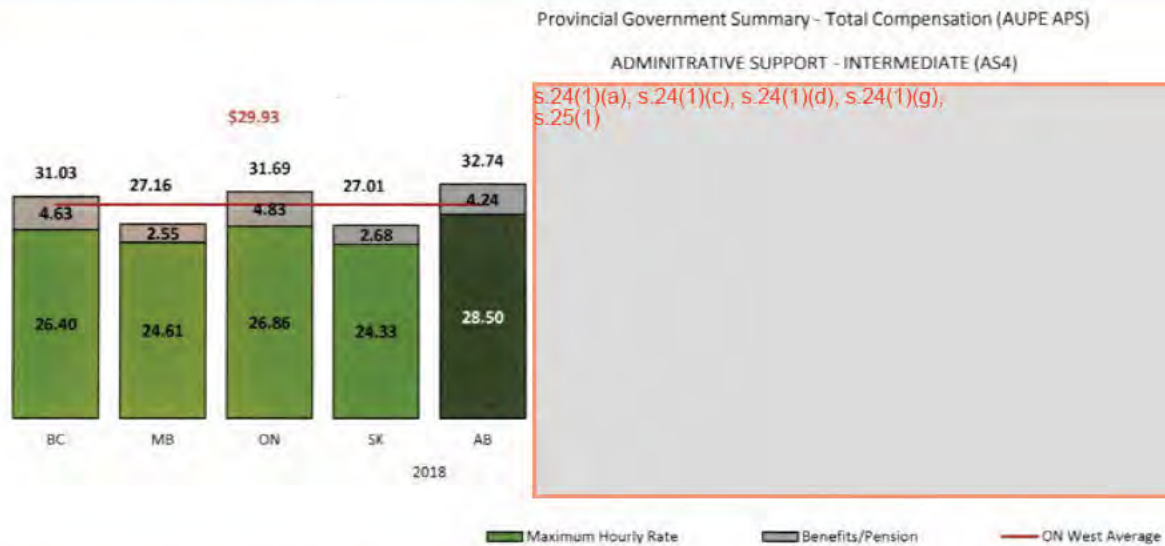

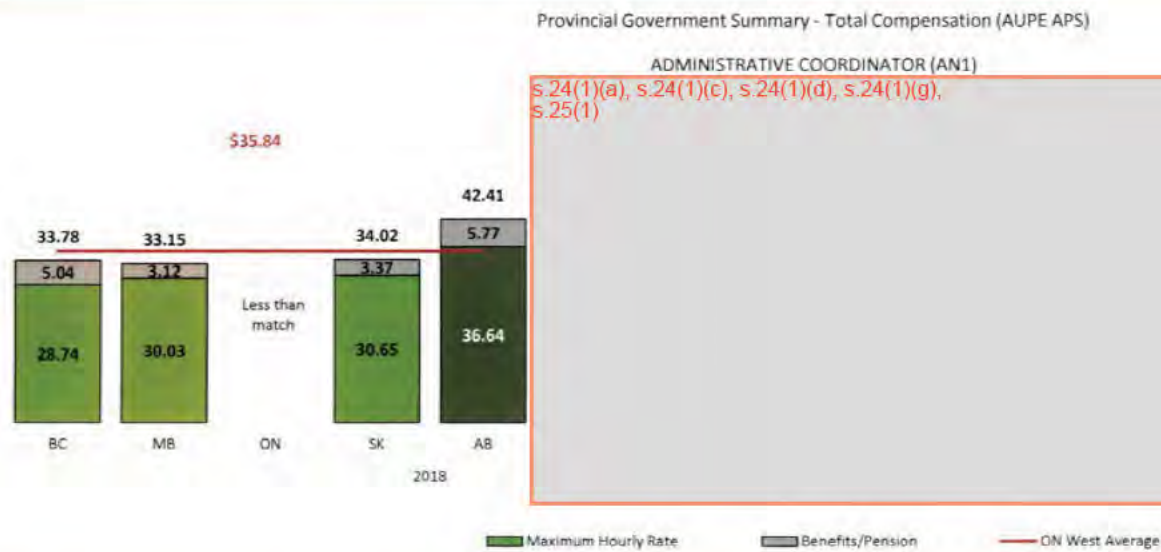

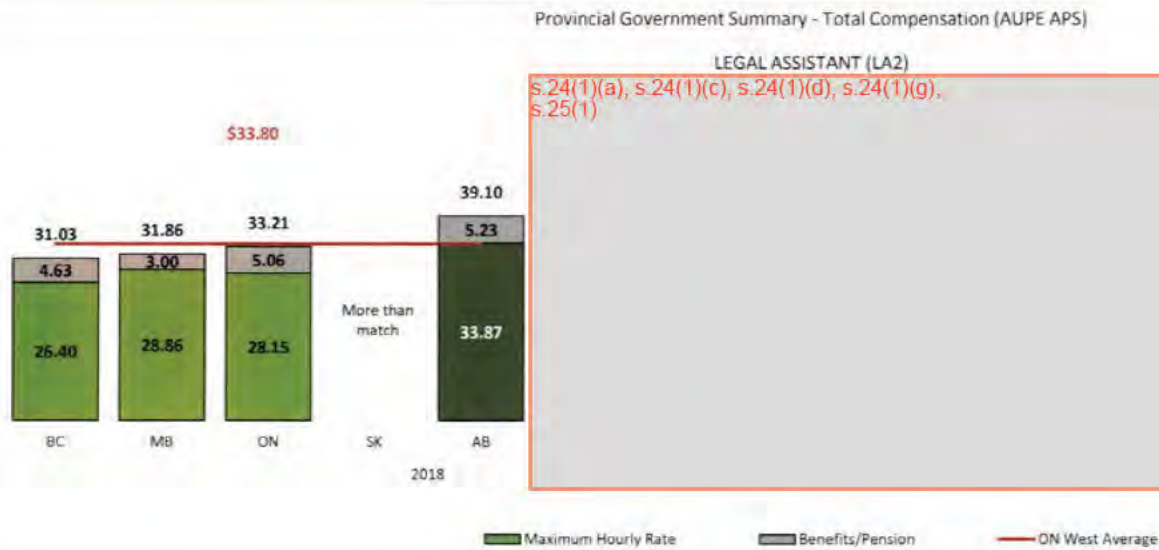

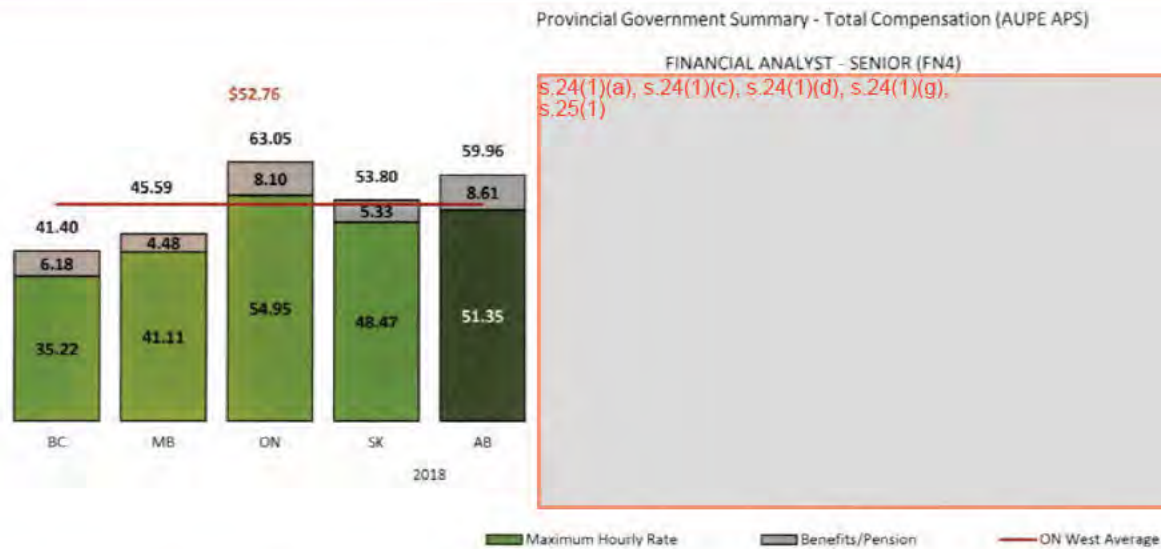

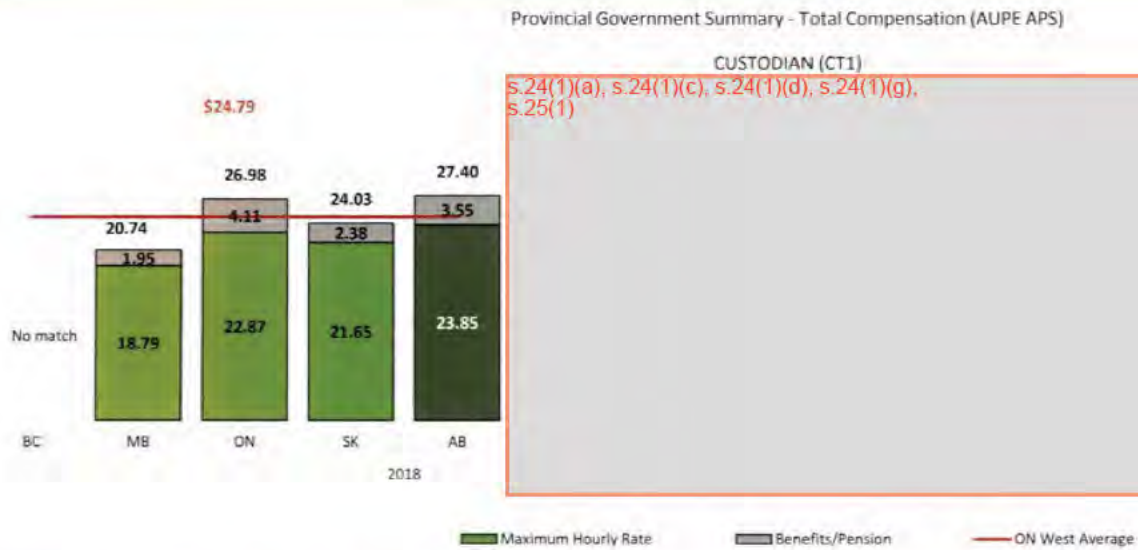

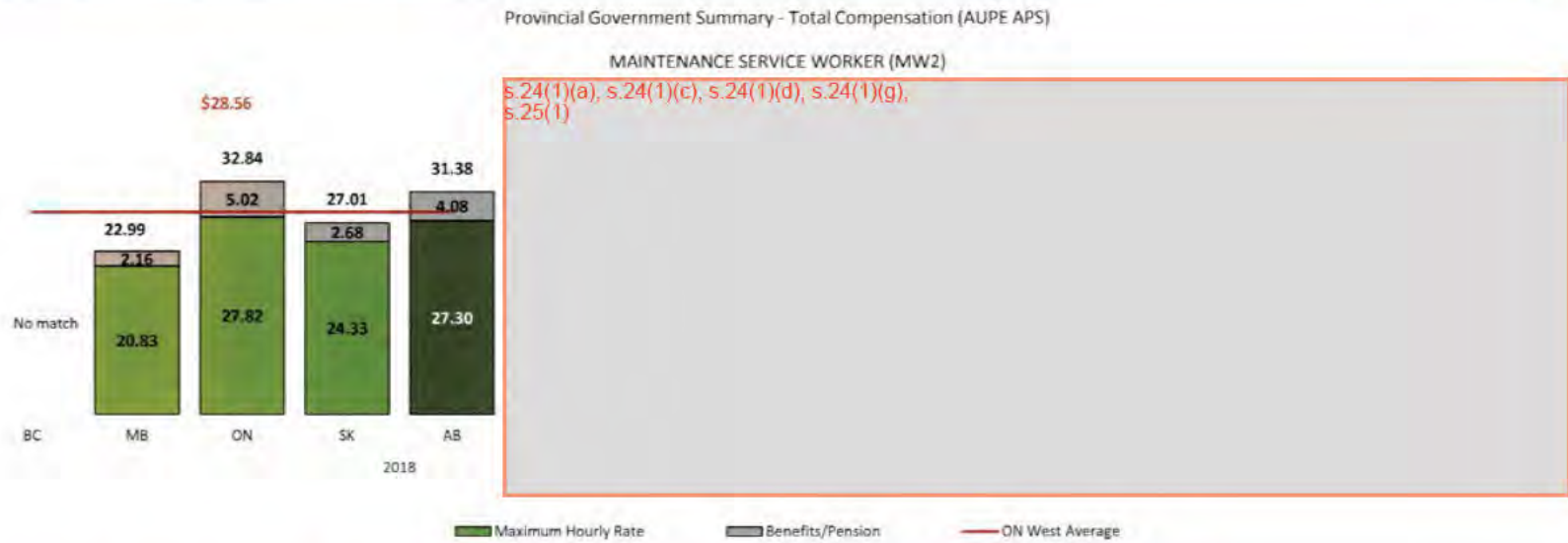

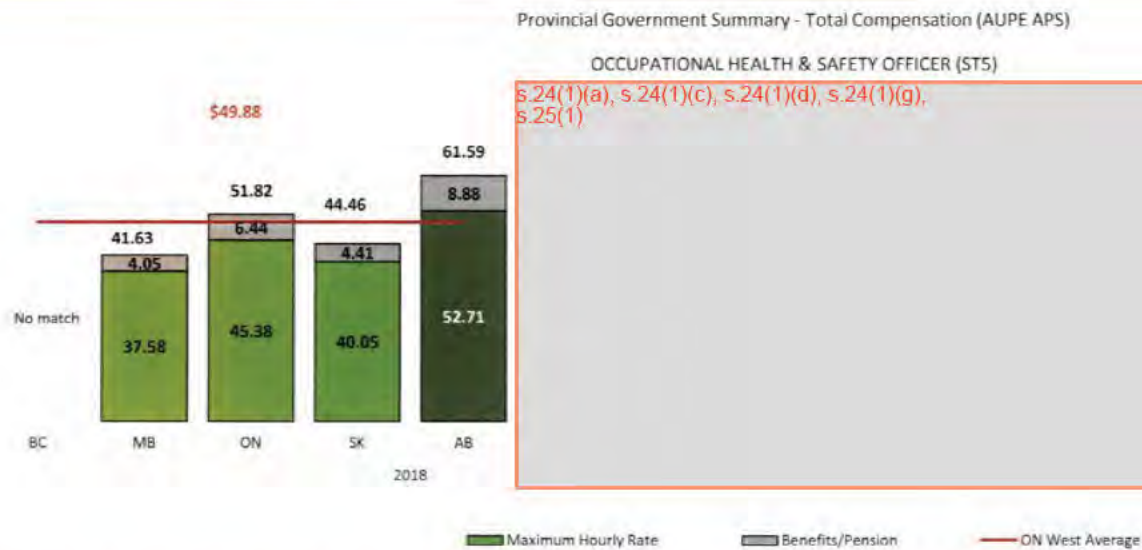

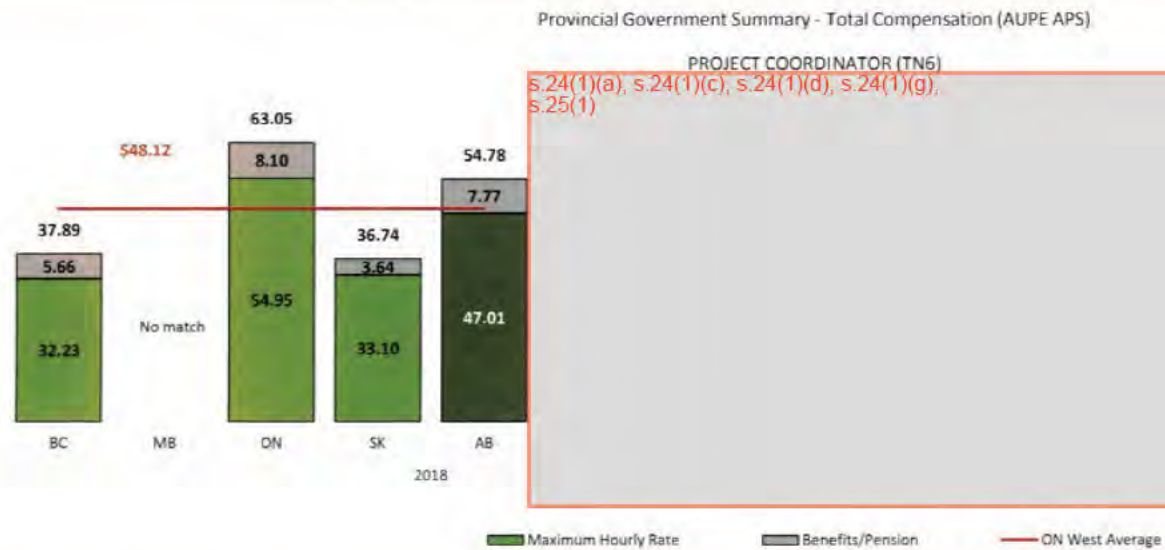
