Which is usually from the inmates who get the jails welfare? That's right they can apply for allowances to buy shampoo and hygienic products but the jail supplies that for free so they use it to buy chips and pop and protein supplement s) so they take the money and on a nice sunny day they have a BBQ for the inmates at the "Treatment Centre".

Now you must really be shaking your head but it gets worst once the BBQ is done and the people that sexually tortured small children have had enough soon they move inside to take part in a card tournament or a bingo game that is held by the jail. This actually comes with cash prizes for the inmates that is paid out by the jail that comes from the unit funds that comes from the canteen that comes from special allowance that comes from the taxpayers yeah I know you have heard it. So what happens if you get knocked out of the tournament and can't win any of that cold hard cash or canteen well grab a seat and watch the Stanley cup playoffs on not one but two of the giant flat screen that the jail has bought for the inmates with our tax dollars and mounted on the wall for them to enjoy.

But wait!

The Sex offenders are not interested in hockey they are more interested in playing the Sony PlayStation 3 that the jail has purchased for them. That's right the Senior Management team at Headingley Correctional Centre that's Superintendent Greg Skelly, Acting Deputy Assistant Superintendent Jamie Wardrop, Acting Assistant Superintendent of Operations Tim Matson and Acting Assistant Superintendent of Programs Josh Cooney have decided that they should spend the days playing PlayStation 3 and Guitar Hero.

I know what you are thinking these men should all be fired! First they have taken the judge's ruling of sentencing a sex offender to a prison term and ignored it and placed them in a "Treatment Center" stocked it full of PlayStation 3 and Giant flat screen TVs and then hold BBQ and bingo tournaments for them with taxpayer dollars.

So in closing once again I apologize to the victims and their families as I was a Correctional Officer and Manitoba Justice had tied my hands and prevented me from doing my job. I apologize to the Winnipeg Police Department for all the hard work you have done. I know that you will be re-doing it because our

recidivism rate continues to rise because they want to come back to jail to play video games have BBQ and use the facilities gym that has more universal gyms and treadmills then shapes. I am sorry to the tax payers who have no clue how much of their hard earned money is wasted day to day to day trying to keep these pedophiles happy rather than using it on safety and security. And lastly I am sorry to all the people that work at Headingely Correctional Centre I know how hard it is for you to show up to work and try and do a job you took an oath to do to the best of your abilities while the Senior Management team there continues to step on you and make you slaves to the inmates!
