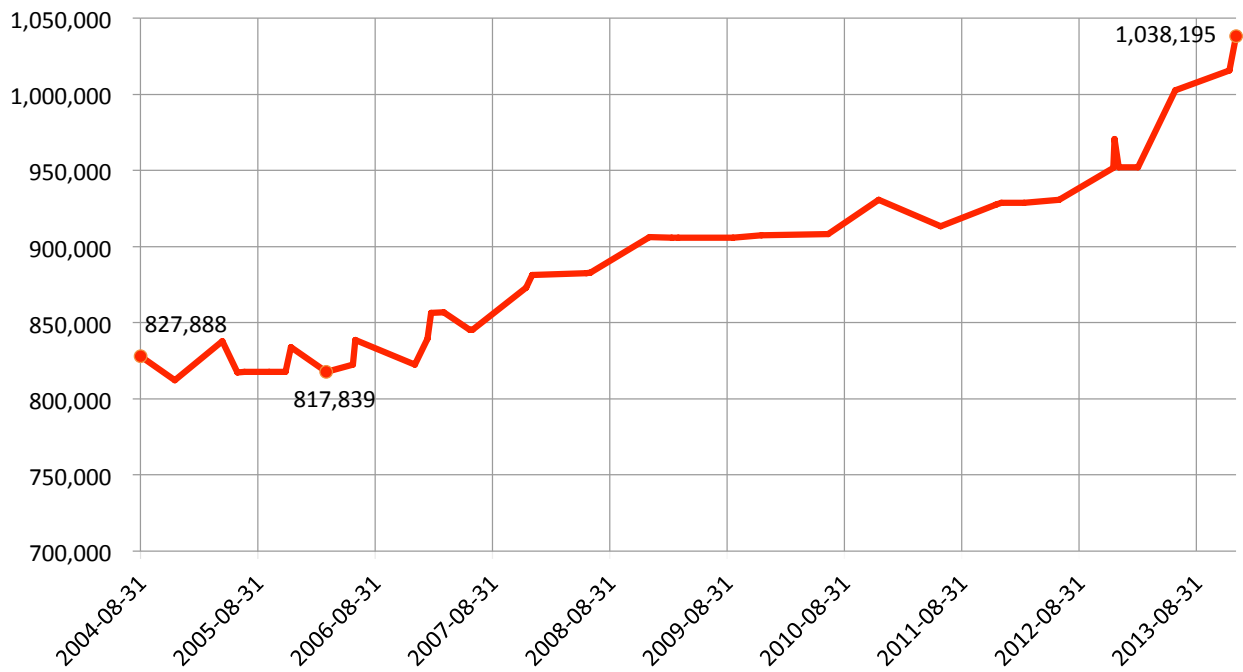
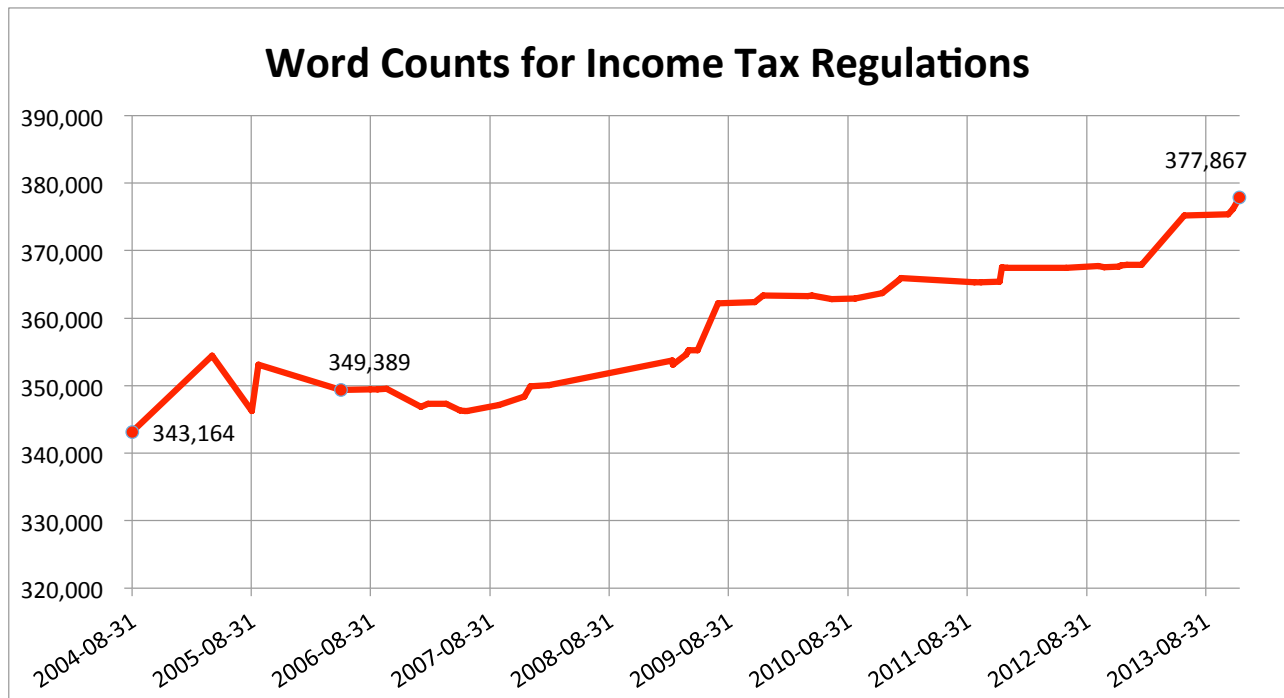


Chart 2: Word Counts for Income Tax Regulations
