Re: Application for Access No. 13-066

Your Application for Access under *The Freedom of Information and Protection of Privacy Act* ("the Act") was received on September 23, 2013.

Application for Access No. 13-066 reads:

"Please provide documentation on any lists of refused or unacceptable personalized licence plates."

In a telephone conversation with Paul Lacroix, MPI Privacy and Information Officer, on September 23, 2013, you clarified your request. You said that you wanted a list of refused or unacceptable personalized licence plate slogans from the last two years.

Response: Please find enclosed a one-page chart that lists the licence plate slogans that were not approved for use as personalized licence plates from March 1, 2011 to September 24, 2013.

By way of background, personalized licence plates cannot include:

- any profane, sexually suggestive, racial or alcohol/drug-related words, phrases or innuendoes that may be considered offensive or suggestive, or political messages of any description, in any language.
- a hyphen at the beginning or end of the slogan.
- a slogan containing consecutive hyphens and/or spaces.
- any combination of letters and numbers that would create an identification problem: Example: 118B5S.

- any combination of letters and/or numbers duplicating or resembling any existing or proposed regular number plate series, or that would create an identification problem.

The Registrar of Motor Vehicles reserves the right to recall personalized licence plates that are later deemed to be inappropriate.
