Thank you for your access to information request received in this office on June 10, 2010, requesting access to documentation of expenditures on promotional items in 2008-09 and 2009-10. This was to include items such as t-shirts, handbags, stress balls, key chains, mugs and other give-away items that are used for promotion (not including brochures, flyers or printed signage). As well, you requested a breakdown of costs associated with sponsorship of events (golf tournaments, hockey tournaments, etc.), teams or groups (e.g. sponsorship of boat racing team, etc.).
