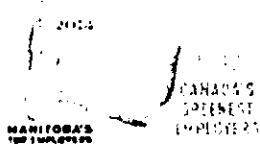
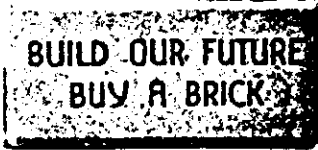

In June 2014, the Board first became aware about a rumour circulating among about marble in the Ms. Forsyth's residence.

The board takes allegations such as these extremely seriously. We immediately asked an external investigator to see if there was any substance to this allegation.

Scrap marble from the the PGI construction is believed to exist in Ms. Forsyth's residence. It is believed that the marble was material marked for disposal.

The report confirmed that the College's vendor did no installation or construction work in the President's residence. Any installation or construction work was not undertaken by the College.

The investigator was asked to examine if any College policies had been broken. The report of the review was provided to the Board on Aug 20 but was unable to determine whether College policies had been broken. This report cannot be shared public, but the board has forwarded the report to the team undertaking the provincial review.

The board received results of the internal review after discussions with Ms. Forsyth regarding her departure were already underway. The report did not contain conclusive findings that would alter these terms.

The board remains committed to ensuring that College policies are followed.
